VVA Meeting of 7/5/2017

Meeting was called to order by Treasurer, Joe Heil at 7 pm. Pledge of Allegiance was led by Sergeant at Arms, Joe Graff and opening prayer was led by Chaplain, Dennis Werlein. Members listed to be kept in our prayers are Dennis Schram, Jim Blaha, Bill Connolly and Dennis Werlein. There were no guests, new members or guest speakers present. Due to unexpected late notice of VFW Post 7232 being closed, tonight's meeting is held at the Eau Claire Elks Club. *"Thank You"* to the Elks Club, and John Dorsey, for the hospitality and making us feel welcomed.

Secretary's Report: Motion made by Dennis Werlein to accept the Secretary's Report for the minutes of last month's meeting as mailed and e-mailed, motion seconded by Joe Graff; motion carried. Election of new Secretary is required following the death of Roger Schuh last month. James 'Mac' McBee accepted nomination of this position, motion made by Dennis Werlein to elect Mac as the Chapter's new Secretary, seconded by Joe Graff; motion carried.

Treasurer's Report: Joe Heil gave the Treasurer's Report and explained that all computer issues have now been resolved. He went on to explain all bank account balances, income received, anticipated expenses and expenses paid; all accounts balance. Motion made by Joe

Graff to accept the Treasurer's Report, seconded by Pat Moore, motion carried. Joe also gave a brief account of the Brat Stand fundraiser that the Chapter sponsored for Shelley Steinke that was just held. Shelley was diagnosed with inoperable brain cancer in March of 2017. The family had approached the Chapter and asked us to act as the non-profit sponsor for the brat stand and split the proceeds between them and us. After a brief discussion, Dennis Werlein made a motion to have all proceeds from this event remain with the Steinke family as they plan to utilize these funds to help with their main fundraiser in August. This motion was seconded by Joe Graff and the motion carried. The main fundraiser for Shelley will be held Saturday, August 12, 2017 at Fall Creek High School from 11 am - 6 pm. President's Report: Mike Korger not present, no report submitted.

Vice President's Report: Larry Wrycza not present, no report submitted.

AVVA Report: National has recognized Julie McBee as Chapter 5's AVVA Representative and voting Delegate, along with recognizing Rick Talford as our Alternate Delegate while Julie is attending the VVA meetings with Mac. Request was made for a \$100 donation for AVVA's Project Friendship 2017. Project Friendship is a program that makes a donation to an organization in the host city of the National Convention which supports veterans. This year that donation will be presented to Volunteers of America Greater New Orleans to help close the funding gap with their programs for homeless veterans which focus on transitional housing, counseling, intensive care coordination, a job training and employment program, and supportive services for low income/homeless veterans and their families. For more information or to send a donation, go to www.VOAGNO.org. Motion was made for the Chapter to donate \$100 to Project Friendship by Dennis Werlein, seconded by Ralph Ottum; motion carried.

National VVA Convention: August 8 – 12, 2017 in New Orleans; McBee's and Talford's will be attending to represent our Chapter. Joe Heil clarified the costs the Chapter had agreed to pay for sending members to New Orleans; all registration fees and luncheon costs for four members paid to National and closing banquet costs for four members paid to State. A brief discussion about the candidates who are running for VVA National office ensued with consensus to vote for the candidates as proposed for National Office and Mike Demske as Region 6 Director. Rick Talford asked who the Chapter preferred for AVVA Region 6 Director, our State Representative, Pat Furno, or current Region 6 Director, Fran Davis; Chapter prefers Fran Davis. All members were encouraged to look over the proposed resolution changes prior to the August Chapter meeting so Mac can vote accordingly.

State VVA Meeting: Julie McBee provided a report from the State Council meeting that was held at Highground on June 17th. Veterans Suicide Prevention program will be held on Friday, September 22nd from 12:00 noon until 6:00 pm in Waupaca to be followed on Saturday, September 23rd with the VVA WI State Council meeting. Joe Heil will not able to attend, if anyone is interested in attending please let leadership know. Veteran Suicide Prevention Program flyer was passed out and membership is encouraged to inform their local Police, Fire, EMT, First Re-

sponders, Clergy, educators, medical personnel, community leaders or families/caregivers that may benefit from this NO COST program. CEU's are available. Membership: Currently 146 members as of May 30, 2017; 116 VVA members and 30 AVVA members.

OLD BUSINESS

Veterans Home: Rory Schutte provided a report on the Veterans Home; all finances are in good order. There will be a Vets Fest on July 8th from 11:30 am to 2:00 pm with tickets \$20 in advance, \$25 at the door and discounted group rates. Members are encouraged to come on out, enjoy the day and visit with the veterans and assist them getting to the picnic pavilion. There will be a motorcycle ride at the Home also that day. On August 8th there will be a Tamburitzan performance at McDonnell High School in Chippewa Falls at 7:30 pm that will be a Recreation Committee fundraiser for the Home. More information as it is available, but a good

turnout is appreciated. Joe Heil has coordinated with DAV 21 for our co-hosted Christmas Party this year and the date has been set for Friday, December 8th so mark your calendars—HoHoHo!

Highground: Joe Graff gave the Highground Report on upcoming events. There will be a bicycle ride scheduled for August 4th and a motorcycle ride scheduled for August 18th-19^{th.} The Fall Fest/Chili Feed will be on October 7th. Find more information at www.thehighground.org. Joe continued by passing around information pamphlets for The Journey Home and the Veterans Wellness Program. He went on to say that the Board of Directors at the Highground gave Kirk and Nancy Rodman a three week trip to Ireland as a retirement present for all their years of service and provided some information on the new manager, John Weilmer, a retired Army veteran whose wife and daughters are already helping out. Note: Dave Zien asked the Chapter to consider sending a "Thank You" letter to Kirk and Nancy for their 19 years of service. Dennis Werlein made a motion to approve a plaque and a Thank You letter for the Rodman's, seconded by Mac McBee, motion carried. A letter and Certificate of Appreciation will be drafted by Julie and we'll discuss how we would like to present it to the Rodman's in August.

Logo/Clothing: More zippered hoodies sweatshirts have been ordered. A flyer was passed around with a lightweight jacket for our Color Guard. Discussion ensued about the future of our Color Guard with members' advancing years/health issues and whether or not we could continue to march in parades. Further Color Guard details for parades will need to be addressed on a one-on-one situation, but we will definitely continue with Funeral and Honor Guard details, as well as for assemblies or meetings which would be indoors and of shorter marching distances. Will have a jacket at the next meeting for everyone to look at and vote on.

Fundraising: Upcoming events are the Northern Wisconsin State Fair from July 12th through 16th in Chippewa Falls; Dunn County Fair from July 26th through 30th in Menomonie; Buffalo County Fair from August 3rd through 6th in Mondovi; Clark County Fair from August 9th through 13th in Neillsville and the Big Rig Truck Show from August 18th through 20th at the fairgrounds in Chippewa Falls. If you are able to help out at any of these events, please contact Julie. A fundraising committee meeting will be scheduled soon and members notified. Continue to sell those raffle tickets so we can have a successful event on October 1st. Aside from selling raffle tickets, don't forget that we need to start requesting donations for door prizes and silent auction items. If you need donation forms, or drop off collected items, contact Julie. We will have new posters printed, along with a donation request cover letter, and these will be available at our August meeting or call Julie if you can't make that meeting and she'll get them to you.

Also discussed was a fundraising opportunity at Pizza Ranch. Julie has spoken to the manager in charge of their fundraising program for non-profit organizations. The program entails having four to six members of an organization bus tables, promote their organization with a portion of that evening's sales, along with tips earned, given to the organization. Available nights are during the week (no weekend night) and they have materials to help organizations promote "their" night so that there is a good turn-out. Summers are slow so she suggested a night in September. When informed of our October 1st Fundraiser, she said she could also set-up a table for us to have flyers and guys sitting there to sell our raffle tickets. Organizations are able to book a

fundraising night once every three months, so we could continue to use this opportunity throughout the year. Right now dates are open in September, we just need to let her know when we would like to book and event. She said that more than four or six to bus the tables' gets cumbersome, but having more than that meant that the work could be divided in shifts so the work wouldn't fall to just a few. She also suggested after Labor Day and the start of school would be a good time.

Julie also reported an opportunity that was mentioned at the State Council meeting of selling beer glasses with the VVA logo (or our Chapter logo) from S. Magnuson Posi-Pour. These are 16 oz. Libby beer glasses that are a nice, heavy-weight glass that the VVA State Council has been selling. The glasses are purchased for \$84/case of 24 glasses, sold for \$5 each and the profits (\$36) go to the State Council's Toxic Exposure Programs. These have been "selling themselves" and if the Chapter wished to have the Chapter logo on the glass, then the Chapter would realize the profits from selling the glasses instead of the State Council. A flyer was passed around so everyone could see what the glasses looked like. After discussion on this, motion was made by Dennis Werlein for the Chapter to purchase two cases of glasses with the Chapter logo, seconded by Joe Graff; motion carried.

Dave Zien stated that for our October 1st Fundraiser, Jerry Allen is available to perform. Jerry is known to the group for his *Dead Man's Hand* movie filming here in Wisconsin and as a performer of his Highwayman Tribute to Waylon Jennings, Willie Nelson, Johnny Cash and Kris Kristopherson. Dave states that the cost would be \$300 and possibly a hotel room. Mac McBee made a motion to approve \$300 to hire Jerry Allen for our Fundraiser entertainment, seconded by Rory Schutte; motion carried. Julie will make contact with Jerry to work out the details.

Eau Claire Veterans Council: Joe Heil reported that DAV van is operating well with two trips made this past week. He further added that the Tribute Park is going forward and donations are now being accepted, with a goal of raising \$1.8 million for the building phase. A Foundation meeting is held every two weeks to go over issues and move things along and pledge forms are now available. The issue with the Community Garden Club is not really with the Tribute project, but with the Eau Claire City Council itself. There have been two large donations pledged; the Altoona VFW Post 10405 and Eau Claire VFW Post 305 have both pledged \$10,000 each. The Lao-Hmong were asked to go back to their membership and have them decide what kind of a memorial design they would like to have for their presence at the Tribute, and report back to the Foundation with the design for approval. There are Pledge Sheets available now and corporations are being approached about large ticket items that could be "sponsored" such as light poles, benches, memorial stones, etc. Individuals or families are also able to sponsor these large items. The formal name to be used for the Tribute will be the "Eau Claire Veterans Tribute Trail".

NEW BUSINESS

A Thank You note has been received from the scholarship recipient from North. The nursing scholarship recipient will be determined by CVTC sometime in September or October.

Ralph Ottum spoke of Abbotsford having their First City Days on August 12th and 13th and requested a donation of some of the Chapter tee shirts for this event; this was unanimously agreed upon. This event will be taking place at the same time as the Clark County Fair in Neillsville. Our Chapter will have a booth at this fair to sell raffle tickets and thanks to the Granton John Deere, we will have a lawn mower on display. If you can help out, give Ralph a call.
