VVA Meeting of 11/1/2017

The meeting was called to order at 7 p.m. by the President, Mike Korger; Pledge of Allegiance and Prayer with a moment of silence led by the Sgt. at Arms, Joe Graff. Joe updated the members about Dennis Werlein's transfer from Sacred Heart Hospital to the American Lutheran Home in Mondovi for rehab; he hopes to be home by Thanksgiving—please keep Dennis in your thoughts and prayers, better yet, stop by and visit (he has therapy in the mornings so afternoon or evenings would be better if you go).

Guest, Bob McRoberts Jr., was introduced by President Korger. Bob Jr. is the son of Chapter member Bob McRoberts and is the owner of My Foot Rx in Bloomer and is a Certified Pedorthist. He discussed the need for foot care, especially for the veteran, who may have neuropathy issues or diabetes and need orthotics or specialty shoes. Through his recent advocacy for his father with the VA recently, he emphasized the need for veterans to communicate with their physicians, either local or through the VA in Minneapolis or Tomah and to involve a patient advocate from the VA if it is felt that the physician is not listening. He spoke of his ability to interface with local or VA physicians to be able to help veterans get fitted for appropriate footwear and how, depending on a veteran's rating, get the orthotics or shoes a veteran is entitled to. Secretary's Report: Motion to accept last month's minutes as either mailed or emailed by Secretary McBee was made by Joe Heil, seconded by Ralph Ottum and motion carried.

Treasurer's Report: Joe Heil spoke of the final numbers for the October 1st raffle/fundraiser, checking and savings accounts all balance after last month's bills have been paid and receipts deposited. Motion to accept the Treasurer's Report was made by Rory Schutte, seconded by Joe Graff and motion carried. Joe Heil then asked for approval to purchase new National VVA flags for the Cadott Veterans Memorial as the flag that was there had been removed due to damage. Motion was made by Pat Moore, seconded by Joe Graff and motion carried.

President's Report: Mike Korger apologized for not being able to attend the last Board of Directors meeting. There was talk of co-sponsoring a trip to Washington, D.C. and he is looking into costs for flights or bus trip. He then asked about how our Outdoor Recreation program was doing; Bill Anderson was not present but it was mentioned that the Chippewa Rod 'n Gun Club had been working with veterans over the summer. Mike spoke of the upcoming Marine Corps Ball to be held November 7th at the Florian Gardens in Eau Claire, any Marine interested should contact him about tickets.

Vice President's Report: Larry Wrycza not present.

AVVA Report: Present at tonight's meeting was Sally and Eric Johnson, Rick and Kristina Talford, Peg Ottum and Julia McBee. Discussed items were possible ideas to brighten the Christmas for the homeless veterans out at Klein Hall; upcoming Chapter election in April 2018 and State Representative election in June 2018 (anyone wishing to run for State Representative needs to file paperwork in January 2018); and fundraiser ideas for 2018.

National VVA Convention: Next National Convention will be in Spokane, WA in 2019.

State VVA Meeting: Reservations need to be made if you plan on attending the Christmas Party December 1st in Waupaca, more information can be found at www.vvawi.org. VA/Benefits: Pete Breed not present. Dave Zien did speak with regards to the State Assembly Bill addressing property taxes paid by veterans. Dave made a motion asking for support of the Chapter members to sign letters he brought with him to the Governor, State Senators and Representatives, Joe Heil seconded and the motion carried. These letters were passed around and members signed them and Dave will deliver these letters on November 16th in Madison. 
Dave Zien has books available for sale from the Military Week Tribute Tour that was held this past May. The week-long tour will also be repeated this fall. For more information, please contact Dave.
