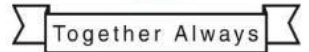

## VVA Meeting of 1/02/2019

Call to Order by President Mike Korger; Pledge of Allegiance and Opening Prayer was led by Joe Graff with a moment of silence for recently departed Bill Labarron of Augusta. Guests present are Mark Beckfield, Eau Claire Veterans Foundation, Adam Kohls, Assistant Eau Claire CVSO, Wes Porter, LaCrosse Veterans Center, and Leroy Jansky, VFW District Commander.

Mark Beckfield and Adam Kohls gave an update as to the progress on the Eau Claire Veterans Foundation's Tribute Trail and received a donation from Chapter 5 in the amount of \$10,000. Wes Porter spoke about the working being done at the LaCrosse Veterans Center and how the services were begun by Vietnam veterans in 1978 and how the re-adjustment counseling program is being used by veterans.

## **REPORTS**

**Secretary** – Due to holiday mail, not everyone has received their copy of the newsletter. Approval of the Secretary's Report will be tabled until next month to give everyone a chance to review the minutes after receiving their newsletter.

**Treasurer** – Joe Heil reported on bank balances and expenses to date; all accounts balance and are in good standing and balance with bank statements. Ralph Ottum made a motion to accept the Treasurer's Report, seconded by Rory Schutte; motion carried. Joe then suggested for the Chapter to purchase a laptop computer to be used for Chapter business, as there was assent to this idea, he will shop around for a good deal and will report back in February.

**President** – Mike Korger reiterated his report as submitted in last month's minutes.

**Vice President** - Larry Wrycza not present, no report.

**AVVA** – Julie reported that there will be another AVVA Pizza Ranch fundraising night on Monday, January 28<sup>th</sup> from 4:00 p.m. until 8:30 p.m. with the thoughts of doing something special for the Women Veterans Retreat Day held in May at Trinity Equestrian Center; seeing Chapter members there to support our efforts will be appreciated. Don't forget to come early to the February 6<sup>th</sup> meeting as the AVVA members will be providing all Chapter members with a soup and sandwich dinner with dessert starting at 5:30 p.m. prior to the regular meeting that night.

**VVA National** – National Convention will be held in Spokane, WA from July 16-20, 2019.

**State Council Meeting** – Next State Council will be held in Waupaca on Saturday, March 16<sup>th</sup>.

**VA Benefits** – Pete Breed talked of veterans who have a 100% disability rating to be sure to check with your CVSO if your disability is permanent that your rating indicates this because a disability and/or illness that improves with care may reduce if not labeled permanent or total. Pete also mentioned the article on Agent Orange in the Nov/Dec 2018 issue of the *Veteran* which gives a good overview of those presumptive diagnoses and disabilities recognized by the VA as being associated with the chemicals used during Vietnam.

**Minority Report** – Dave Zein reported that there was approximately \$2,400 received in donations for the Christmas Tree Program in which 277 were cut and donated from Wisconsin Adventures on Wheels in Willard. Dave also talked about the additional Living Legacy signs that are being dedicated to the Hmong and Dennis Werlein this coming May 13<sup>th</sup> at the Roadside Diner on Menomonie Street.

## **OLD BUSINESS**

**Vets Home** – Rory Schutte reported that the Home received a donation of a picture from the American Legion of Rome, WI. A Veterans Ball is being planned for November 11<sup>th</sup> from 4:30 p.m. to 6:30 p.m. with a cost of \$20/person. Rory also shared the most recent Veterans Home Newsletter and Events Calendar; there are several opportunities for volunteers to assist with outings and events at the Home. More research on raffle items is being done and a committee meeting will be held to discuss options to present to the membership by the next Chapter meeting.

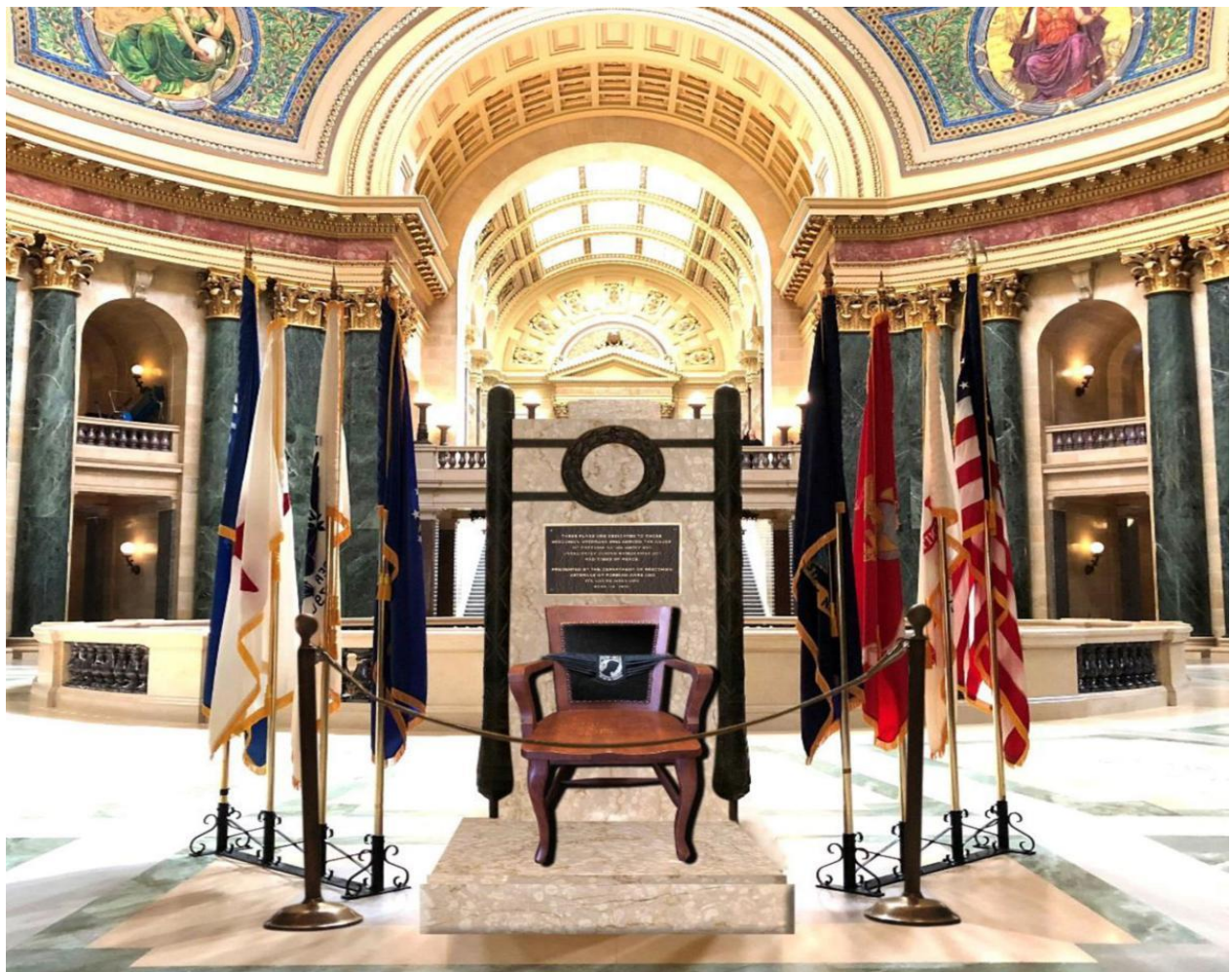

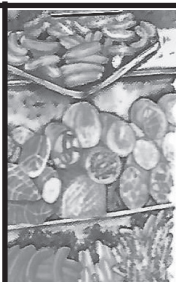
