VVA MEETING OF APRIL 3, 2019

Call to Order by President Mike Korger, Pledge of Allegiance and Opening Prayer given by Joe Graff. There was a roll call of all in attendance to Welcome all Veterans and guests.

REPORTS

Secretary – A motion to accept the minutes as reported in the newsletter, mailed and emailed, made by Dennis Wood Sr., seconded by Mike Smith; motion carried.

Treasurer – Joe Heil provided information on all accounts, which are all in good standing and balance with bank records. Joe was thanked for his report.

President – Mike Korger reported that he attended four Vietnam Veterans Day events over the past week; The gathering held at L.E. Phillips Senior Center; the Ho Chunk National event where he received a jacket for attending; the Vietnam Veterans Day event held at the Eagles Club in Lake Hallie where he received a book from the Lao Vietnam Veterans on General Vang Pao; and the Rusk County Vietnam Veterans Day event held at the Drop Zone VMA in Ladysmith.

Vice President - Larry Wrycza not present, no report.

AVVA – Rick Talford gave an update on the By-Law/Policy & Procedure proposal he has submitted. It appears there is no other candidate running for the Region 6 Deputy Director position and that he is the only candidate—Chapter 5 will have a member representing them on the National level. The next Pizza Ranch fundraiser will be Wednesday, April 17th from 4-8:30 p.m. A thought to think on, the AVVA members would like to split the cost of a stone at the Eau Claire Veterans Tribute Trail with the VVA members commemorating Chapter 5.

VVA National – National Convention will be held in Spokane, WA from July 16-20, 2019. Chapter will have three voting VVA delegates (Mac McBee, Joe Graff, and another) with one voting AVVA delegate (Rick Talford). The Chapter will pay the registration fees and consider reimbursement for costs connected to travel, etc. A motion to pay these costs was made by Joe Heil, seconded by Dennis Wood Sr.; motion carried.

State Council Meeting – Next State Council will be held on June 15th at the Highground in Neillsville. Chapter five will have eight voting delegates. All required paperwork and financials have been filed as required.

VA Benefits – Dave Mayenchein brought up that veterans with a disability rating over 50% can get a conservation permit for \$10. Jerry Bertram brought up an article that was in the recent VFW magazine that states the government is looking into taxing veteran benefits to help pay for deficits. Pete Breed requested that the Chapter draft a letter against this action and made a motion for such a letter to be drafted, seconded by Dan Zeigler; motion carried. It was also noted that independent letters should be sent to legislators with a closing statement of, "Please understand I will be sharing your reply with other veterans."

Minority Report – Dave Zein absent.

OLD BUSINESS

Vets Home – Rory Schutte and Joe Heil spoke on the recreation committee's desire to place an additional seven or eight benches outside (they have the funds for this) and some discussion on the need for more patient lifts so that each wing would have their own lift rather than sharing one lift for all four wings. Highground - Joe Graff provided some dates for upcoming events: Maggie Mae, April 13, 2019; Spring Cleaning at the Willard Wheels of Adventure site, April 20-22; Legacy Stone placement on April 27th; Highground Spring Clean-Up, May 8-11. Future events for August 2020 will be a Vietnam traveling wall along with the Canadian wall and it is requested that the Chapter provide security at least one night of the stay.
